INSTITUTIONAL ROADS PROGRAM UPDATE

Executive Summary: The Board Office requests Board approval of the **Institutional Roads Program Update**, which would add \$4.901 million to the \$12.5 million Five-Year Institutional Roads Program approved by the Board in September 2023, making it a \$17.4 million Five-Year program.

> Per the Board's *Policy Manual* §2.3 section 1.A.ii, Board approval of the Institutional Roads Program is required.

Background: In November 2023, the Iowa Department of Transportation informed the Board Office that \$4.901 million in DOT Institutional Road Program funds were available as of January 2024. These DOT funds became available through adjustments to future DOT Road Use Tax Fund income projections and updates to past, current and future Regent road project budgets.

About the Iowa DOT's "State Parks and Institutional Roads Program":

The Iowa DOT's "State Parks and Institutional Roads Program" is funded by the Road Use Tax Fund (RUTF), which is state-shared revenue created in 1949 by the Iowa Legislature and enshrined into the Iowa Constitution to assist state, county and city governments with the construction, repair and maintenance of the state of Iowa's road infrastructure.

Per *lowa Code* §307.24, the DOT's "State Parks and Institutional Roads Program" provides 65/100 of one percent of the RUTF for the construction, reconstruction, improvement and maintenance of roads and streets located on all state land, including the Regents. The Regents' annual allocation is 30 percent of this amount.
