PROPOSED 2024-2025 COMMON AND UNIVERSITY / PROGRAM SPECIFIC FEES

Action Requested: Consider the proposed changes to Common and University / Program Specific Fees for the 2024-2025 academic year as highlighted in blue in the spreadsheets on pages 2-6. Justifications may be found on pages 7-12.

Executive Summary: Common and University / Program Specific Fees are assessed only to students that use these services based on their programs, interests or needs. Students may pay one or more fees as presented in this memorandum for the direct costs associated with using additional miscellaneous services provided by the universities. These fees are separate from tuition and mandatory fees.

Final Board approval is required prior to implementation of the fee changes. Board action on these fees is scheduled at the next meeting. Adoption of these fees is subject to revision at a later date if cost recovery is different than the original estimate.

Background:

Board Policy Manual §1.6H: (1) requires the Board to review and approve all new institutional or college-wide fees over \$1 per semester and all departmental fees over \$10 per semester; and (2) encourages the three universities to work together to establish common titles and amounts for fees. Some differences in fee titles and amounts may remain because of the unique nature of some programs and services at each institution.

Iowa Code §262.9(19) requires the Board to take action no sooner than 30 days after notification of the proposed fee changes to presiding officers of each student government organization at each affected institution. Written notification of the proposed fee changes will be sent to the student government presidents at each of the universities.

Billing Fees

- ◆ Additional Statement\$8 - ELIMINATE

Rationale: To cover the cost of mailing paper statements via USPS mail. This fee is rarely assessed as students and families have become accustomed to and often prefer online billing options.

Refund Schedule Fees

Rationale: To simplify and automate the tuition adjustment process as a result of the transition to Workday. ISU aims to shift from two refund schedules to just one. This will improve efficiencies, reduce student confusion and improve transparency of financial impacts to students. The proposed changes align refund fees and reduced load fees and is fair to all students by ensuring consistent treatment. The refund schedule provides some flexibility to students in the first ten days of the semester and supports student success by encouraging part-time enrollment, registration for more classes, and on-time registration before the first day of class.

Transcript Fees

- ◆ Special Handling Charge (early transcript; partial transcript)\$5 - ELIMINATE

Rationale: This fee covers costs of providing same-day transcript service or other requests that require immediate or special handling. This legacy fee is obsolete.

- ◆ Annual Program Fee – Non-Resident.....\$37,540 to \$38,850

Rationale: To keep up with increasing costs, meet student needs, and enable the Realizing Educational and Career Hopes (REACH) program to expand services to students. The goal is to ensure the program has adequate financial support to cover program costs while keeping REACH as affordable as possible.

The REACH Program is a unique transition certificate program for college students with disabilities, such as autism, intellectual disabilities, and learning disabilities. REACH empowers young adults to become independent members of the community. Students can enroll in the program for up to four years with early graduation options after year two. Students live in university housing, take a full course load, further develop independent living skills, and work at a variety of community internships. Coursework, campus life and career experiences prepare students to reach their full potential.

Annual Program Fees provide the necessary financial support for an essentially self-sufficient REACH program and cover the following: personnel, operations, curriculum and program development, marketing, program evaluation and REACH course instruction expenses. Its budget also includes expenses associated with internship development, web-based and on-site post-program follow-up activities, and support of the student alumni group. A critical component of this program is developing relationships with families and students across time and maintaining a low student to instructor ratio to provide the support needed for student success.

Quality programming and the required support for students with complex disabilities necessitates a skilled staff, which the program maintains at a staff to student ratio of less than 1:3. REACH employs approximately 26 undergraduate student mentors to assist with classroom support and campus life. The program employs student Resident Assistants (RAs) and two evening staff for the two-year program to support REACH students in the residence halls so that access to staff is available 24/7.

REACH is approved as a Comprehensive Transition Program by the Department of Education, allowing REACH students to apply for federal Pell grants, thus making the REACH program more affordable. Further, through the generosity of donors, REACH is able to offer partial scholarships to students with financial need.

Rationale: To be increased at the rate of the general tuition increase.

College of Liberal Arts and Sciences

- ♦ Health Coach Assessment Fee.....\$125 - NEW

Rationale: To offset the cost charged to the University by the National Board for Health & Wellness Coaching to maintain approved program training status. This fee is for students who take the Practical Skills Assessment after successfully completing the Health Coach Pathway.

College of Nursing

- ♦ Professional Liability Insurance (MSN & DNP Programs)\$13 - NEW

Rationale: To offer liability insurance to graduate students.

Based on student feedback, the College of Nursing consulted with SUI’s Risk Management (UIRM) about whether the liability insurance policy covering undergraduate nursing students can be made available to graduate nursing students. Several other health sciences colleges assess graduate students similar fees associated with liability insurance. If newly enrolled graduate students are added to the liability insurance policy through SUI’s Risk Management, they would not need to purchase individual policies. This is a substantial cost savings for students.

College of Pharmacy

- ♦ Assessment Fee (PharmD 4th Year).....\$100 - NEW

Rationale: To pay for a tool provided by a third-party vendor. The tool helps the program assess the readiness of and prepare students for taking the North American Pharmacist Licensure Examination.

- ♦ Professional Liability Insurance (MSN & DNP Programs)\$17 - NEW

Rationale: To fund liability coverage for PharmD students.

PharmD student interact with patients during training and are routinely required by out-of-state health facilities to have medical liability insurance during rotations. Students also see patients at UIHC and other in-state locations. The state of Iowa insures employees working at state institutions such as UIHC, however students are not considered employees in this setting; thus, the need for this coverage.
