## APPROVAL OF 2024-2025 TUITION AND FEES & COMMON AND UNIVERSITY / PROGRAM SPECIFIC FEES

#### Action Requested: Consider approval of:

- 1. The proposed tuition and mandatory fees for the 2024-25 academic year as outlined in this memorandum, effective with the Fall 2024 session.
- 2. The allocation of the Regent universities mandatory student fees for the 2024-25 academic year as provided on page 8.
- 3. The proposed Common and University / Program Specific Fees for the 2024-25 academic year as provided on pages 15-19.

**Executive Summary:** Consistent with the Board's strategic plan, determining and fulfilling appropriate resource needs are essential in providing high quality public education, cutting-edge research, and needed public services. Predictability, transparency and long-term planning strategies are woven throughout the plan.

The Board considers the total resources necessary to maintain and strengthen the Regent universities. Regent institutions need adequate support from all sources, while promoting the effective use of resources to meet institutional missions and to maintain the quality of education lowans expect. In recent years, the Board has collectively examined the two main resource components available – tuition and state appropriations – as well as the reallocations/efficiencies necessary to strengthen Iowa's public universities.

At its September 2023 meeting, the Board requested an appropriations increase for FY 2025 (2024-2025 academic year) of \$14.8 million for the general university appropriations that support Regent higher education. As passed by the General Assembly and signed by the Governor, the general university appropriations were increased \$12.3 million (2.5% increase) for FY 2025 when compared to the current year.

While considering the state support, operating costs that may be absorbed through efficiencies and reallocations, and the expected inflationary impact to higher education budgets, the proposed tuition rates in this memorandum for the 2024-25 academic year includes base undergraduate resident increases of 3.0% for SUI and ISU and 2.0% for UNI (\$270 at SUI and ISU; \$168 at UNI). The universities also propose varying tuition rates for non-resident, graduate and professional students as well as differential rates for certain higher cost programs.

## **Undergraduate Tuition and Mandatory Fees**

The proposed 2024-25 base tuition and mandatory fee rates for undergraduate resident and nonresident students are provided below. A summary of mandatory fees is provided on page 4 and a comprehensive list of all proposed tuition and fee rates for each university is on pages 9-12.

Funding from the proposed tuition increases will help address growing financial challenges including inflationary cost increases, recruiting and retaining faculty and staff in national markets, meeting collective bargaining terms, deferred maintenance needs in academic facilities, and student financial aid to provide higher education opportunities to more students.

In addition to the base undergraduate resident and nonresident tuition increases, the universities request the following differential tuition rates for specific higher cost programs as described below. Assessing tuition in this manner aligns costs where they are incurred rather than spreading them over the entire student population.

## STATE UNIVERSITY OF IOWA

The Radiation Sciences Program of the Carver College of Medicine is requesting a tuition increase of \$1,617 for on-campus resident and non-resident undergraduate students for Fall 2024. This is the year-two request of a three-year phasing in of tuition increases to ultimately reach a balanced budget. The increase is needed to fully fund the Radiation Sciences Program. The program is essential to SUI's mission and the University of Iowa Hospitals and Clinics, as it provides healthcare personnel in the areas of diagnostic imaging and radiation therapy. There are critical shortages of these healthcare personnel. A review of peer institutions with Undergraduate Baccalaureate Degrees in Radiation Sciences demonstrates that SUI's target tuition is comparable, particularly when looking at programs associated with academic medical centers.

#### IOWA STATE UNIVERSITY

Beginning last year, ISU's Ivy College of Business proposed to align tuition rates for sophomore students majoring in business with junior and senior business majors over a three-year period. Once fully implemented, the differential tuition rate structure will be further simplified for sophomore, junior, and senior-level undergraduate classifications in these degree programs. The rates will then also align with sophomore, junior and senior students in engineering, agricultural systems technology and industrial technology majors. For the second year of the three year phase-in, the College proposes an increase of \$1,340 for applicable resident students and \$2,476 for non-residents beginning Fall 2024. Sophomore business students have intensive hands-on or experiential components (such as formal and informal interactions with the faculty, involvement in industry consulting projects and case-based learning, smaller section sizes similar to upper-level students, and access to a growing number of programs and increased opportunities for double-majors, certificates and minors).

#### UNIVERSITY OF NORTHERN IOWA

UNI is requesting supplemental tuition for the nursing program (BSN) of \$1,944 (equal to that of business students) to support the simulation and lab equipment costs for the newly created program. Normal annual costs are anticipated to exceed \$100,000 with software and maintenance contracts, with periodic costs of repair and replacement being much higher. These costs mirror those of other BSN programs within the state, and are anticipated to keep increasing due to some contracts being linked to number of students in the program and due to inflationary costs. This supplemental tuition rate would match the current tuition rate for students in the Wilson College of Business, and is critical to funding the BSN program's needs for effective student learning and meeting ACEN accreditation requirements.

Variances from the base rate proposals for certain graduate programs for SUI and ISU are provided below.

#### STATE UNIVERSITY OF IOWA

- College of Law: The College of Law proposes a 3.5% increase in the non-resident tuition rate.
- Carver College of Medicine (CCOM):
  - $\circ\,$  The CCOM proposes no increase in the resident and non-resident tuition rate for MD students.
  - The Master of Science in Athletic Training program proposes no increase for both resident and non-resident students.
  - The Doctor of Physical Therapy proposes no increase in tuition for both resident and non-resident students.
  - The Master of Clinical Nutrition program proposes a 3% increase in the tuition rate for resident students and no increase for non-resident students.
  - The Physician's Assistant program proposed a 2.5% increase in tuition for resident and non-resident students.
- College of Nursing Graduate Programs: To remain competitive, the College of Nursing proposes no increase in the tuition rates for resident and for non-resident graduate students.
- College of Pharmacy: The College of Pharmacy proposes a 0.75% increase in the tuition rates for resident and non-resident students in the PharmD program.

#### IOWA STATE UNIVERSITY

- Veterinary Medicine ISU proposes a 5% increase to Veterinary Medicine resident students and 3.5% for nonresident students enrolled in the highly ranked program. Veterinary education is an intense mix of classroom instruction and clinical learning in both teaching laboratories and a modern referral teaching hospital. The additional revenue will enable ISU to deliver state-of-the art learning experiences for veterinary students, and a positive working environment for faculty and staff; to maintain and upgrade diagnostic equipment, imaging equipment, and medical supplies, while incorporating new technological advances; and to support faculty as leaders in veterinary curriculum development and teaching.
- Executive MBA Program This program has a defined two-year curriculum directed at a cohortbased demographic of senior business leaders. The program began in the fall of 2019 and the tuition rate has remained unchanged since its inception. The proposed 10% tuition increase is

necessary to cover cost increases in instruction, materials, and participant travel. There are currently 27 business executives enrolled in the program.

# **IOWA BOARD OF REGENTS**

Interdepartmental Graduate Programs - ISU requests approval to change the tuition assessment
practices for graduate students in interdepartmental majors. These graduate programs span
multiple departments across the university and are not offered by a specific department or
college, but by faculty who represent that major. Tuition rates currently align with the home
department of the student's major professor. The new 2024-2025 recommended approach is to
instead align the tuition rate with the student's declared program of study. This proposal treats
students pursuing the same degree equitably, regardless of the home department of their major
professor, and will increase cost transparency for prospective students. Additionally, the change
will improve operational efficiency, align tuition rates with the cost of instruction, and support the
goal of growing enrollment in interdepartmental programs.

# Inflation

Inflation impacts higher education in the same manner it affects other segments of the economy. While the Board determines tuition increases well in advance of the actual expenditure of funds, the Board consider inflation's impact in evaluating tuition and fee rates. According to a report released by the U.S. Labor Department's Bureau of Labor Statistics on April 10, 2024, core inflation (which excludes food and energy due to their volatility) exceeded 5.5% in 2021 and 2022 before slowing to 3.9% in 2023. The annual core inflation rate for the 12 months ending in March 2024 was 3.8%.

# Mandatory Fees

Mandatory fees, charged to each student, provide a distinct resource to respond to specific needs of students. Provided below are the proposed 2024-25 mandatory fees for each university.

#### UNIVERSITY OF IOWA

SUI proposes an overall increase in mandatory student fees of \$49.

- Technology As shown on the previous page, the University recommends a 4% increase (\$24 to the standard rate) in Technology Fees. The net new revenue generated from these increases will fund inflationary increases in IT expenditures that support students.
- Health The proposed \$4 increase to the Health Fee will support higher costs for medical supplies, pharmaceuticals, and personnel.
- Mental Health University Counseling Service requests a \$7 increase to the mental health fee to address staff limitations and expand clinical hours devoted to student clients.
- Student Activities On behalf of the undergraduate and graduate student governments, SUI requests a \$4 increase in the activities fee to provide additional support for the student-run radio station, University Lecture Committee, and additional late-night safety initiatives.
- Recreation A \$10 increase is proposed to offset increased operational and programming costs of the recreation facilities.

#### IOWA STATE UNIVERSITY

ISU proposes an overall increase in mandatory student fees of \$20.

- Technology Fee High quality, reliable and accessible technology is fundamental to all components of ISU's mission. Information Technology Services (ITS) enhances the student experience, protects student privacy, and supports digital accessibility by way of modern and useful technology and software. ITS is requesting an annual Student Technology Fee increase of \$10 (2.7% to the standard rate) per student to support the increase in student-related software license costs.
- Building Fee The Memorial Union (MU) serves as a hub for student life and activities. The requested \$3 increase (3%) for the MU will stabilize their budget and keep up with inflationary measures which directly impact their ability to reinvest in MU's infrastructure.
- Recreation Fee Recreation Services is funded almost entirely from student fees. Given inflation
  in recent years, it is necessary to increase the fee \$7 (2%) to keep up with the increased costs
  of goods, equipment, services, and personnel. The Student Affairs Division plans to request a
  small increase each year or every two years rather than requesting periodic larger increases.

# UNIVERSITY OF NORTHERN IOWA

UNI proposes an overall increase in mandatory student fees of \$40.

- Technology UNI proposes a \$9.00 increase to the technology fee to support the maintenance and expansion of institutional technology support systems and services including the UNI's learning management system (LMS), lecture-capture system, video conferencing services, polling systems, testing services, classroom technologies, data network connectivity and services, assistive technologies, computer laboratories, software subscriptions, online content and learning systems. The increase will help deliver select artificial intelligence tools in support of teaching, learning, and the student experience.
- Health Student Health Services ensures student access to essential health services, including medical, counseling and wellness services. The number of visits for counseling and office visits has increased in recent years and this funding is vital to continue to provide these services to our students. A \$6.00 increase to the Health Fee is proposed to support Student Health Services.

- Student Activities The proposed \$7.00 increase will help provide revenue to sustain current
  programs and services including student organizations, fine arts programs, student newspaper,
  and activities sponsored by the Campus Activities Board and Student Life.
- Student Services The proposed student services fee reflects a \$9.00 increase to provide needed revenue to support intercollegiate athletics. This fee also provides tickets for students to attend athletic events.
- Building The proposed \$2.00 increase to UNI's building fee will help address building renewal needs in the student union and the Fieldhouse.
- Recreation UNI proposes a \$7.00 increase to the recreation fee will support increased operational and programming costs and allow Recreation Services to maintain existing programs and services for students.

## Common and University / Program Specific Fees

Common and University / Program Specific Fees are assessed only to students that use these services based on their programs, interests, or needs. Students may pay one or more fees as presented in this memorandum for the direct costs associated with using additional miscellaneous services provided by the universities. These fees are separate from tuition and mandatory fees. The Board received the first reading of the proposed Common and University / Program Specific Fees rates at its May 10, 2024 meeting. These fees are provided on pages 15-19 and remain identical to those presented to the Board in May.

#### Estimated Cost of Attendance

<u>lowa Code</u> §262.9(19) requires the Board to publish the estimated total cost of attending the Regent universities, including room and board and other costs, at the same time that it publishes final tuition and mandatory fees.

Based on the proposed base tuition rates, room and board rates, and other costs, the following table estimates the total cost of attendance for a resident undergraduate student.

Other costs, as quantified for financial aid calculations, include the universities' estimates of student costs for books, supplies, transportation and personal expenses.

# **Allocation of Mandatory Fees**

<u>lowa Code</u> §262.34B authorizes a student fee committee comprised of five students and five employees at each university to make recommendations for the distribution of revenues from student activity/service fees to the university president. The allocation proposals are consistent with the recommendations of the student fee committees. Building fees are allocated among enterprises to ensure minimum bond coverage ratios are met.

The statute requires Board approval of the allocation of these student fees. Proposed fee allocations represent efforts to provide opportunities for students to participate in student organizations and activities.

# Part-time Tuition and Mandatory Fees:

The proposed 2024-25 part-time tuition and fee rates for resident and nonresident undergraduate and graduate courses at the three universities are consistent with the proposed tuition and mandatory fee rates for full-time students. Resident and nonresident rates for part-time students with differential tuition are based on the corresponding full-time tuition rates.

Undergraduate and professional part-time tuition and mandatory fees are based on 12 credit hours, while graduate part-time rates are based on 9 credit hours.

Some proposed mandatory fees for part-time students as well as summer sessions may vary among the universities as described below.

#### Student Health fees

 ISU – full fee assessed to all students taking 5 or more hours per semester; no fee assessed to student taking less than 5 credit hours

Student Health Facility fees

ISU – full fee assessed to all students regardless of the number of credit hours taken

## All other mandatory fees

For undergraduate students:

SUI, ISU and UNI – assessed at 75% of the full semester rates for 6 through 11 hours and at 50% for less than 6 credit hours

For graduate students:

- SUI assessed at 75% of full semester rates for 4 through 8 hours and 50% for less than 4 credit hours
- ISU and UNI assessed at 75% of full semester rates for 5 through 8 hours and 50% for less than 5 credit hours

## Summer school

- SUI & ISU computer fees assessed at full semester rate; maximum of other fees assessed at 50%
- UNI assessed at 50% of the full semester rate
