Board President Report

President Bates read a resolution in honor of Regent Michael Richards, who was serving in his final meeting:

WHEREAS, Mike Richards was appointed to the Board of Regents by Governor Branstad on May 6, 2016, and reappointed to the Board by Governor Reynolds in 2021; and

WHEREAS, he was elected the 22nd President of the Board on May 1, 2017, and was re-elected in 2018, 2020 and 2022, with his seven years in that role making him the longest-serving Board President in nearly 20 years; and

WHEREAS, during his tenure, successful searches were conducted for all three university presidents and the Board's executive director, leading to the hiring of outstanding people in each of those key positions; and

WHEREAS, the universities have continued to expand and provide tremendous benefits to lowa, combining to add nearly \$15 billion in income to the state's economy during the 2021-22 fiscal year, and university activity supporting one out of 10 jobs in lowa; and

WHEREAS, he provided leadership to the Regents institutions through the unprecedented COVID-19 pandemic, declaring a state of emergency and providing guidance and a steady voice through incredibly difficult times; and

WHEREAS, he was a driving force behind the Board's 50-year, \$1.165 billion publicprivate partnership with the University of Iowa's utility system; and

WHEREAS, during his tenure, the Board approved hundreds of millions of dollars in capital projects at the Regents institutions, including constructing new and renovating existing academic, residential, athletics and other facilities; and there was tremendous expansion at the University of Iowa Hospitals and Clinics, including the opening of the Stead Family Children's Hospital, construction of the new North Liberty hospital, and the purchase of Mercy Iowa City; and

WHEREAS, he was a key player in the formation of the Board's Tuition Task Force in 2017, which involved multiple public meetings to discuss tuition rates and the funding of lowa's Regent universities; and

WHEREAS, he was a champion of freedom of speech, establishing the first public comment period at Board meetings, as well as the Board's free speech committee, which led to 10 directives adopted by the Board that strengthened the universities' efforts in free speech; and

WHEREAS, he established the Board's diversity, equity and inclusion study group, which after a comprehensive review led to 10 directives being adopted by the Board on issues related to DEI; and

WHEREAS, he led the Regents Enterprise through significant structural changes, including the sale of the Iowa Braille and Sight Saving School property, the transfer of oversight of the Iowa School for the Deaf to the Department of Education, and the transition of Iowa Public Radio into an independent entity;

NOW THEREFORE, BE IT RESOLVED that the lowa Board of Regents expresses its deep gratitude to Regent Richards for his expertise and dedication, and publicly acknowledges him for his extraordinary service and contributions to the Board of Regents, its institutions, students, families, and all Iowans.

Reports from Institutional Heads

Presidents Wendy Wintersteen, Barbara Wilson and Mark Nook presented updates on their respective campuses.

ISU Faculty Presentation

President Bates recognized Aaron Sadow, the David C. Henderson Professor in the ISU Department of Chemistry, who presented his research titled Transforming Plastics: Science and Technology to Convert Waste Into a Sustainable and Economical Feedstock for Chemicals and Fuels

Salary Policies

President Bates recognized Board Counsel Aimee Claeys who introduced representatives from faculty and staff groups who are not organized for the purposes of collective bargaining to present on FY 2025 salary policies. Representatives included UI Faculty Senate President Edward Gillan, UI Staff Council President James Jorris, ISU Faculty Senate President Sarah Bennett-George, ISU Professional and Scientific Staff Council President Nathan Arndt.

DEI Directives Update

Presidents Wendy Wintersteen, Barbara Wilson and Mark Nook presented updates on Diversity, Equity and Inclusion efforts on their respective campuses.

Regent Barker asked if the institutional heads were preparing for the DEI directives included in Iowa Senate File 2435. President Nook stated that the universities would need more time to interpret the law as it applies to the Regent Universities.

Regent Cramer noted that he liked the universities approach in combining services to serve all students, rather than dividing students and hoping to serve each division.

Regents Cramer and Barker both noted that Iowa Senate File 2435 supersedes the original Board of Regents DEI directives and that the universities will need to find ways to comply with the law. President Wilson noted that what the universities are doing is in the spirit of the law, but that the institutions also need to comply with federal and state laws and accreditation procedures. Wilson also offered that the goal of the universities is to serve and welcome all students.

President Bates acknowledged the work of the campus leaders and their committees in response to the DEI directives passed by the Board in November 2023. Bates noted that the success of students is the top priority for the Board and the universities and that maintaining compliance of federal and state law, grants, contracts and accreditation is of paramount importance for the success of students. She stated that the universities are unique and that variations on how the campuses implement the directives are expected.
