OPENING REMARKS

Vice President for Medical Affairs Dr. Jean Robillard provided opening remarks to the Committee.

▶ OPERATING AND FINANCIAL PERFORMANCE

CEO Ken Kates and Interim Associate Vice President and CFO Doug True gave a presentation on operating and financial performance.

In response to a question from Regent Sahai, CEO Kates and VPMA Robillard explained the timing between when faculty departs and successors are hired.

In response to a question from Regent Dunkel, CEO Kates elaborated on why salaries and wages were less than the 2017 budget indicated and updated the Committee on the nursing shortage.

In response to a question from Regent Boettger, CEO Kates discussed the challenge of providing appropriate care for psychiatric patients and President Harreld noted increased efforts to prepare social workers, psychologists, nurses, etc. Regent Bates said not all care facilities are equipped with appropriate staff to care for these patients and thanked UIHC and SUI for their efforts to provide skilled workers in these areas.

In response to a question from Regent Sahai, VPMA Robillard talked about the role of telemedicine and reimbursement from insurance companies. CEO Kates said UIHC offers several nursing homes tele psychiatry to extend services beyond lowa City.

▶ TRANSPARENCY IN QUALITY, SAFETY AND SERVICE

VPMA Robillard welcomed Chief Medical Officer Dr. Theresa Brennan and Chief Quality Officer and Associate Chief Medical Officer Dr. Michael Edmond. Drs. Brennan and Edmond gave a presentation on quality, safety, and service at UIHC.

In response to questions from Regents Bates and Dakovich, Dr. Brennan discussed patient satisfaction surveys response rates and efforts to gather adequate volumes for each provider.
