The Board met at 2:15 p.m., December 11, 1958, with President Hagemann in the chair and Mr. Dancer secretary of the meeting. (The Board meeting was preceded by meetings of the Educational Policy Committee and the Building and Business Committee which began at 9:30 a.m.)

GENERAL OR MISCELLANEOUS

The following business relating to general or miscellaneous matters was transacted on December 11, 1958:

DORMITORY PROGRAM - FACILITY FINANCING. At the meeting held on November 13-15, 1958, Secretary Dancer was requested to make arrangements with William Blair & Company to have a representative visit with the Board about its proposed plan for financing facilities. (See page 167, Board minutes of November 13-15, 1958.)

Edward McC. Blair and Stänford Madson, of the firm of William Blair & Company, Chicago, Illinois, appeared before the Board and cutlined what they called a different approach to financing dormitories and other facilities at universities.

On motion, which was seconded and passed, the proposed plan was referred to the Finance Committee for further study and report back to the Board.

EXECUTIVE SESSION - RECESS, The Board resolved itself into executive session at 3:30 p.m. At 4:30 p.m. the Board arose from executive session and President Hagemann stated that the Board would take a recess until 9 a.m., December 12, 1958.

December 12, 1958

The following business relating to general or miscellaneous matters was transacted on December 12, 1958:

PURCHASE OF EQUIPMENT - POLICY. At the meeting held on October 23-25, 1958, the formulation of a policy or procedure for the purchasing of equipment and supplies was referred back to the Building and Business Committee for further study and report back to the Board. (See Board minutes of October 23-25,1958, page 91.)

The Building and Business Committee recommended that equipment and supplies be purchased by the institutional Business Manager acting through the institutional Purchasing Agent on the basis of quotations, except when special circumstances indicate otherwise.

Mrs. Rosenfield moved that the foregoing recommendation of the Building and Business Committee be adopted, and the motion was seconded by Mr. Stevens and passed.

TUITION AND FEES - SURVEY AND COMPARISONS. Mr. Gernetzky distributed copies of a report of tuition and fees charged at the State University of Iowa, the Iowa State College, the Iowa State Teachers College, and at comparable institutions in other states.

The presidents of the State University, the Iowa State College and the Iowa State Teachers College were requested to designate a staff member of their respective institutions to serve as a special committee of three to study the matter of tuition and fees and suggest some criteria or bases that could be used in arriving at a policy with respect to fixing tuition and fees in connection with the item "Long Range Planning and Issues" that appears on the docket.

APPROVAL OF MINUTES. On motion, which was seconded and passed, the minutes of the meeting the State Board of Regents held on November 13-15, 1958, were corrected and approved.

STUDY COMMITTEE ON HIGHER EDUCATION IN ICWA. President Hancher stated that it was his understanding that Gaylord M. Couchman, President of the University of Dubuque and also President of the Iowa College Presidents Association, would appoint a special committee of three to draft necessary legislation for an appropriation for the Study Committee on Higher Education in Iowa, and to see that it is introduced into the 58th General Assembly and supported. (See page 97, Board minutes of October 23-25, 1958.)

IOWA JOINT COMMITTEE ON EDUCATIONAL TELEVISION. At the meeting held on October 23-25, 1958, further consideration of the report prepared by the Sub-Committee to Correlate Current Programming, Iowa Joint Committee on Educational Television, was carried over until the next meeting.

President Hancher, President Hilton, and President Maucker recommended that the current program of the Iowa Joint Committee on Educational Television be continued during the 1959-1961 biennium on much the same basis as the present program, and that no request be filed with the legislature for funds for an expanded program.

Secretary Dancer stated that the budget of the Iowa Joint Committee on Educational Television for the next biennium should be increased by approximately \$5,400.00 annually to cover the cost to WOI-TV of televising the programs, beginning July 1, 1959, the increase to be paid 50% by the State Department of Public Instruction and 50% by the State University, the Iowa State College, and the Iowa State Teachers College. The total annual budget for continuing the present educational television program during the 1959-1961 biennium would be approximately \$12,900.00.

On motion, which was seconded and passed, the recommendation of the presidents relative to the program of the Iowa Joint Committee on Educational

Television was accepted, subject to concurrence by the State Board of Public Instruction.

COUNSELING AND GUIDANCE PROGRAMS FOR FRESHMEN. At the meeting held on October 23-25, 1958, the presidents of the State University, the Iowa State College, and the Iowa State Teachers College were requested to report to the Board about the counseling and guidance programs for freshmen. (See page 101, Board minutes of October 23-25, and page 146, Board minutes of November 13-15, 1958.)

Millard Kratochvil, director of the Office of Student Affairs, and J. C. Schilletter, director of Residence Halls, reviewed the programs of the Iowa State College for the counseling and guidance of freshmen; and President Maucker told about the programs at the Iowa State Teachers College.

STATE FAIR EXHIBITS. The presidents of the State University, the Iowa State College, and the Iowa State Teachers College recommended that the exhibits of the institutions under the State Board of Regents for the state fairs be discontinued, effective with the 1959 State Fair; and Mr. Gillette moved that the recommendation be accepted. The motion was seconded by Mr. Barlow and passed.

DORMITORY OPERATIONS - REPORT FOR 1957-1958. Mr. Walsh distributed copies of a report dated December 4, 1958, regarding the operation of dormitories, married student housing and food service at the State University, the Iowa State College, and the Iowa State Teachers College for the year 1957-1958. President Hagemann stated that the report should be discussed at the next meeting of the Board. (See Board minutes of June 19-20, 1958, page 378.)

INVESTMENTS - REPORT. Mr. Gernetzky submitted a statement of the investments made by the Finance Committee during the month of November, 1958,

58th GENERAL ASSEMBLY - LEGISLATIVE PROCEDURE. The procedures for handling legislative matters were discussed, and it was agreed that unless by specific request no contacts should be made with members of the legislature or with state officials without the knowledge and sanction of the Board's central office in Des Moines; that the Finance Committee should be informed at all times by members of the State Board of Regents and institutional personnel of contacts that are made and information furnished; and that all reports should be transmitted through the Board's office.

58TH GENERAL ASSEMBLY - CIVIL SERVICE BILL. It was agreed that if a civil service bill is introduced into the 58th General Assembly all employees under the State Board of Regents should be exempt from the provisions of such a bill.

NEXT MEETING. The next meeting of the State Board of Regents was scheduled to be held in the Board's office in the State Office Building, Des Moines, Iowa, on January 15-16, 1959.

IOWA SCHOOL FOR THE DEAF

The following business relating to the Iowa School for the Deaf was transacted on December 12, 1958:

REGISTER OF PERSONNEL CHANGES. Upon the recommendation of the Educational Policy Committee the actions reported in the register of personnel changes at the Iowa School for the Deaf for the month of November, 1958, were approved and ratified.

SALE OF LAND - LEWIS TOWNSHIP SCHOOL DISTRICT. At the meeting held on November 13-15, 1958, the Finance Committee was authorized to request the Attorney General of Iowa to draw up an option agreement for the sale of a tract of about 23 acres belonging to the Iowa School for the Deaf to the Lewis Township School District. (See page 103, Board minutes of October 23-25, 1958, and page 168, Board minutes of November 13-15, 1958.)

The following option contract was submitted, and the Building and Business Committee recommended that the option be granted:

KNOW ALL MEN BY THESE PRESENTS:

That the State Board of Regents of the State of Iowa, hereinafter called the first party in consideration of \$1.90 and other good and valuable considerations, to first party in hand paid by the Lewis Township School Board, hereinafter called the second party, do hereby grant unto the second party the option to purchase certain acreage consisting of approximately 23 acres in the $NW_{\frac{1}{4}}$ $SW_{\frac{1}{4}}$ and $SW_{\frac{1}{4}}$ $SW_{\frac{1}{4}}$ Sec. 8 - Twp. 74N Rge 43W Pottawattamie County now owned by the state and extending west from Highway 375 to the Wabash Right of Way from the present land owned by Lewis Township District on the South to the land belonging to Ben Sieck on the North so as to eliminate the remainder of any piece of land between the proposed purchased land the present boundary of State School land. (A more detailed description to be established and furnished by a surveyor.) Upon the following terms and conditions to wit:

- 1. Said option shall continue until and including the 30th day of June, 1959.
- 2. The purchase price of said real estate shall be \$750.00 per acre.

 The actual amount of land shall be determined by a qualified surveyor.

- 3. The second party shall have the land surveyed by a qualified person, such person to be approved by the first party prior to the survey. The approved surveyor shall furnish a suitable legal description and plat of the land in quastion at the expense of the second party.
- 4. The second party shall pay all prior cost of appraisal made as a direct result of this option and will pay for any expense to secure an abstract.
- 5. The second party agrees that the patent transferring title to the real estate referred to herein shall contain the following clause:

Provided that in case the real estate described herein shall not be used exclusively for school purposes, the same shall revert to and become the property of the State of Iowa.

- 6. Possession of said premises is to be given second party upon full settlement and upon the delivery to the second party of a proper patent executed by the State of Iowa transferring title; it being understood and agreed that right is reserved in first party to the 1959 crop or crops planted prior to delivery of said patent.
- 7. Final settlement shall be made as soon as funds for said purchase are available by public bond issue, it being understood and agreed that said bond issue, if approved, will allow the funds to be available for final settlement not later than said June 30, 1959.
- 8. This option may be exercised by written notice sent by registered mail addressed to the Business Office of the Iowa School for the Deaf, Council Bluffs, Iowa, Pottawattamie County.

IN WITNESS WHEREOF said parties have hereunto set their hands in triplicate this _____ day of November, 1958.

Mr. Strawman moved that the foregoing option contract be approved, subject to approval by the Executive Council of Iowa, and that the Secretary of the State Board of Regents be authorized to sign it. The motion was seconded and on roll call the vote was as follows:

LEAVE OF ABSENCE. Upon the recommendation of the Educational Policy Committee and President Hancher, the Reverend Robert J. Welch, associate professor in the School of Religion, College of Liberal Arts, was granted a leave of absence without salary or insurance for the second semester of the academic year 1958—1959 and the first semester of the academic year 1959—1960.

ENDOWMENT FUNDS - THE BENJAMIN F. SHAMBAUGH FUND - JOHN F. MURRAY ENDOWMENT FUND - CONGER REYNOLDS ACHIEVEMENT AWARD TRUST. Copies of the will of Bertha M. H. Shambaugh, establishing The Benjamin F. Shambaugh Fund, the will of Bessie Dutton Murray, establishing the John F. Murray Endowment Fund, and the trust agreement creating the Conger Reynolds Achievement Award Trust, with related papers, were distributed to members of the State Board of Regents for study and

COURSE IN ORTHOPTICS - FEE AUTHORIZATION. The Educational Policy Committee reported that the following recommendation had been submitted:

That a fee of \$58 be established for the twelve-month non-credit course in Orthoptics, effective February 1, 1959, one-half the fee to be paid at the time of registration (February or September) and the balance on the alternate date; this fee to include student activity privileges, to permit students enrolled in the course to be housed in University dormitories, and to make them subject to all University rules and regulations; fees may be refunded by the Registrar on the refund schedule previously approved.

Upon the recommendation of the Educational Policy Committee, establishment of the proposed fee for a course in Orthoptics was carried over until further information and a report about the offering of any similar courses are received.

INSURANCE - FINE ARTS OBJECTS. The Building and Business Committee reported that the State University had received quotations for insurance on fine arts objects. (See page 176, Board minutes of November 13-15, 1958.)

Upon the recommendation of the Building and Business Committee the low quotation of the American Central Insurance Company, Policy No. 1FA 825580, Caldwell Insurance Agency, Iowa City, Iowa, for overall coverage on fine arts objects for a net premium of \$367.95 for three years, beginning December 21, 1958, was accepted, and the Business Manager of the State University was authorized to purchase that insurance.

HAWKEYE APARTMENTS (MARRIED STUDENT HOUSING) - REFRIGERATORS AND STOVES. The Building and Business Committee reported that the State University had received quotations for 192 refrigerators and stoves for the Hawkeye Apartments, and copies of the tabulations of the quotations were distributed.

SURVEY OF POWER PLANT - REPORT. At the meeting held on February 13, 1958, the proposal of the Brown Engineering Company for making an analysis of the costs of generating electrical energy at each of the institutions, to determine the economic advantage or disadvantage of generating electrical energy, was accepted. (See Board minutes of April 11, 1957, December 12-13, 1957, January 9-10, 1958, February 13-14, 1958, and page 431, June 19-20, 1958.)

Mr. Kenneth R. Brown and John V. Gebuhr, of the Brown Engineering Company, Des Moines, Iowa, appeared before the Board and submitted copies of a report entitled "Investigation and Report - Electric Generation Costs - State University of Iowa". The summary and recommendations in the report are as follows:

"Summary.

"It has been found that the cost, including equivalent fixed charges, of generating electrical energy at the State University of Iowa averages \$0.00691 per kilowatt hour. This is \$0.00409 per kilowatt hour less than the lowest estimated rate at which electrical energy could be purchased from independent private utilities.

"It is estimated that by continuing operations utilizing extraction type turbines, the University will save approximately \$1,423,000 in operating costs in the 12-year period from 1958 through 1970.

"It was also determined that straight condensing operation of the turbines would increase the turbine heat rate from the present average of 12,397 Btu per kilowatt hour to 17,420 Btu per kilowatt hour. The fuel cost for this type of operation would increase from \$0.00472 to \$0.00664 per kilowatt hour. This operation would result in an overall cost of \$0.00883 per kilowatt hour. The estimated annual savings in the 1958-1970 period, if straight condensing openation were utilized, would average \$62,930, or \$755,160 for the 12-year period.

"Recommendations.

It is recommended that the University continue generation of its own electrical energy requirements. It is further recommended that the University continue its practice of billing such activities as residence halls, laundry, Memorial Union, University hospitals, and other non-academic users for the power supplied to them from the University Power Plant. Electrical requirements should be charged for at rates which will produce revenue for the University Power Plant in excess of the cost of generation, but these rates should also be lower than rates for equivalent electric service furnished by outside sources.

"It is recommended that cost accounting of utility services be instituted and that financing of capital improvements for utility services be done by bond issues payable from earnings from the sale of utilities and from annual allocations of University operating funds rather than by lump sum appropriations made by the Iowa Legislature as capital improvement needs occur. Present State Statutes make no provision for this type of financing. Methods of financing should be studied and Legislative authority should be requested to permit this type of capital improvement financing.

"It is further recommended that power plant accounting be instituted which will accurately reflect the capital improvement costs for electric generation.

"Present plans for adding gas burning equipment to two boilers should be supported. This improvement will result in fuel savings estimated to exceed \$15,000 per year.

"The request for capital improvement funds for increasing the steam line to the campus is recommended as a "must" for proper utilization of the operating economies now inherent in the plant, but which are limited due to the lack of capacity in the steam distribution system.

"It is recommended that the University inaugurate immediately a long range program of increasing steam operating conditions to 250 psig, 500 F. All new additions or alterations should be specified for these conditions. Initially, two boilers and the two 3,000 kw turbine generators can be converted to approximately these conditions at a capital improvement cost of less than \$100,000. This investment will return \$15,000 in the first year, in the form of fuel savings, and the return will increase to an estimated annual savings in excess of \$25,000 by 1970.

BURGE HALL - DINING SERVICE COMPLETION - ACCEPTANCE. The Building and Business Committee reported that on December 2, 1958, Mr. Jenks for the State University and Mr. T. E. Foster for the contractor inspected the Walk-in Cooler. Dining Service Completion, Burge Hall, and found that the contractor, Low-Temp Insulations, Omaha, Nebraska, had completed the work in accordance with the plans and specifications and contract documents.

Upon the recommendation of the Building and Business Committee the Walk-force Cooler, Dining Service Completion, Burge Hall, was accepted as of this date, December 12, 1958, from the contractor, Low-Temp Insulations, Omaha, Nebraska, and payment of the final estimate in accordance with the provisions of Chapter 573, 1958 Code of Iowa, was authorized.

BURGE HALL - MISCELLANEOUS SERVICES COMPLETION (UTILITIES COMPLETION) ACCEPTANCE. The Building and Business Committee reported that on December 2,
1958, Mr. Peck for the State University and Mr. Hannah for the contractor,
Robbins Electric Company, Moline, Illinois, inspected the electrical work of
the Miscellaneous Services Completion (Utilities Completion), Burge Hall, and
found that the contractor had completed the work in accordance with the plans
and specifications and contract documents.

Upon the recommendation of the Building and Business Committee the electrical work of the Miscellaneous Services Completion, Burge Hall, was accepted as of this date, December 12, 1958, from the Robbins Electric Company, Moline,

IOWA STATE TEACHERS COLLEGE

The following business relating to the Iowa State Teachers College was transacted on December 12, 1958:

REGISTER OF FERSONNEL CHANGES. Upon the recommendation of the Educational Policy Committee the actions reported in the register of personnel changes at the Iowa State Teachers College for the month of November, 1958, were approved and ratified.

SALARY ADJUSTMENT. Upon the recommendation of the Educational Policy Committee and President Maucker, the salary of Harland Samson, instructor and trainee in Distributive Education, was changed from \$5,850 to \$6,750 for the academic year effective as of November 1, 1958. Mr. Samson is to be assigned 1/5 time to work for the State Department of Public Instruction for the period November 1, 1958, to June 3, 1959, as a temporary replacement for Mr. Edwin Nelson, and the State Department of Public Instruction is to reimburse the College 1/5 of his present salary rate plus \$100 a month for seven months.

LEAVE OF ABSENCE. Upon the recommendation of the Educational Policy Committee and President Maucker a leave of absence without salary was granted to Dr. R.R. Fahrney, professor of History, for personal reasons, for the period January 26, 1959, to June 3, 1959.

STUDENT FEES - ADVANCED PAYMENT. Upon the recommendation of the Educational Policy Committee and President Maucker the following proposal for advanced payment of student fees was adopted:

1. For all new, full-time, undergraduate students seeking admission to Iowa State Teachers College for the academic year, an advanced payment on fees will be required. This payment will be due within two weeks after the student has been notified of the acceptance or conditional acceptance of his application for admisson. This will become effective for the fall

semester 1959.

For all students, except those with Student Aid Scholarships, the amount of the advanced payment will be \$50. For the student with a partial fee exemption, the amount of the advanced payment will be \$20.

- 2. The advanced fee payment will be refunded if the student notifies the Office of the Registrar of his desire to cancel his admission by August 15 for the fall semester enrollees or by January 1 for the spring semester enrollees.
- 3. Cancellations received after August 15 (or January 1) will not entitle applicant to any refund of the advanced payment. Where unusual circumstances would seem to justify the making of refunds after the above date(s), (e.g., serious illness, entering the armed forces), the decision as to whether a refund is warranted will be made by the Registrar.
- 4. If the advanced fee payment has been forfeited, the entire sum (either \$20 or \$50) will go into the general fund.
- 5. No advanced payment on Student Fee will be required of Graduate Students.
- 6. In addition to this advance payment, it is planned to continue the present \$15 room deposit for students who plan to live in a college residence hall.

CAMPUS LABORATORY SCHOOL - RECREATION AND ATHLETIC AREA, GROUNDS DEVELOPMENT - SITE GRADING - CONCRETE WORK - ACCEPTANCE. The Building and Business Committee reported that the site grading and the concrete work in connection with the Grounds Development of the Recreation and Athletic Area, Campus Laboratory School, had been inspected by representatives of the Iowa State Teachers College and the contractor, and they found the work had been completed in accordance with the plans and specifications and contract documents.
