1. Welcome—Wendy Wintersteen, Chair

7. Topics for Fall and Spring ICCPHSE Meetings—Patricia Draves, Chair

Rachel Boon noted some cross-sector issues that could be discussed:

- free speech issues;
- e-transcript project with K-12, community college partners and regents and privates;
- Iowa Consortium for Higher Education in Prisons.

President Draves noted that incoming freshman may need special support coming into this school year; could discuss any strategies/info/updates between the group. There could also be a discussion about the Condition of Higher Education report, especially data about financial support. Rachel noted that there will be changes to FAFSA filing in the next year, so next year may be a good time to talk about that.

President Wintersteen noted that we should talk about mental health as well as free speech issues. President Fisher also noted free speech as well as preparedness, or lack thereof, of incoming students. Rachel Boon singled out the mental health piece. Alison Jepsen noted that Brad Niebling from the Department of Education would be a good resource on this topic, and President Fisher noted that we could bring in counselors from the campuses. President Wintersteen suggested having institutions share their innovative strategies around mental health for students. Rachel Boon and Laura Dickson can work together to send something out to the listserv for the group to submit their strategies and can note any that we may want to learn more about or we can share the suggestions with the entire group.

Rachel Boon suggested that e-transcript be a topic at the spring meeting; there should be more information at that point. The mental health topic would be better if addressed at the fall meeting. Rachel Boon noted that Mark Wiederspan (Iowa College Aid) might be able to present the enrollment report to the group.

Consensus seems to be (for now) that the fall meeting should be virtual and the spring meeting can be in-person. President Wintersteen offered ISU as host for the spring meeting. The fall meeting will be held (virtually) on Tuesday, October 26, 2021. To avoid the many activities on college campuses in April, it was suggested we look at the last week of March.

The Executive committee decided the spring meeting would take place at the Student Innovation Center located at: 606 Bissell Rd, Ames, IA on the Iowa State University campus on March 31, 2022 from 1:00 - 3:00 pm.
