1. Approval of Minutes

Fred Moore presented the minutes from the December 6, 2000, meeting.

2. Treasurer's Report

John Hartung presented a statement of the Council's income and expenditures for the period of November 1, 2000, through February 28, 2001. As of February 28, 2001, the Council had a balance of \$17,549 of which \$14,429 was in the operational expense account, \$1,910 in the Way-Up Conference account, and \$1,210 in the Carol Kay Memorial Fund account.

Action: The treasurer's report was approved as presented.

3. Coordination (Program Notifications)

A. New Business

1. Briar Cliff College

Briar Cliff College notified the Council of its intent to offer the following programs:

A. Undergraduate Major—Management Information System (On-Campus)

<u>Action:</u> Robert Lester moved that the notification be accepted without concern. Roger Foelske seconded the motion, the motion was unanimously approved.

B. Undergraduate Major—Graphic Design (On-Campus)

<u>Action</u>: John Hartung moved that the notification be accepted without concern. Robert Koob seconded the motion, and it was unanimously approved.

2. <u>Des Moines Area Community College</u>

Des Moines Area Community College notified the Council of its intent to offer an Associate Applied Science Degree in Architectural Drafting (On-campus in Ankeny).

5. Southwestern Community College

Southwestern Community College notified the Council of its intent to offer an Associate Applied Science Degree in Business Systems Networking (On-campus).

<u>Action:</u> Roger Foelske moved that the notification be accepted without concern. John Hartung seconded the motion, and it was approved unanimously.

6. <u>University of Iowa</u>

The University of Iowa notified the Council of intent to offer a Bachelor of Arts Degree in Women's Studies (On campus).

<u>Action:</u> Robert Koob moved that the notification be accepted without concern. David Neil seconded the motion, and it approved unanimously.

7. Buena Vista University

Buena Vista University notified the Council of its intent to offer the following programs:

- b. Undergraduate Major-Health Services Leadership (Off-Campus at LeMars, Iowa)

<u>Action</u>: Robert Koob moved that action on these requests be delayed until the Council's next meeting so that notification guidelines may be followed. David Neil seconded the motion, and it was approved unanimously.

B. Old Business

Robert Barak distributed a list of academic programs that are currently being offered by post-high school institutions in the state of lowa that were not previously approved by the Council. The institutions have notified the Council of their intent to continue offering the programs and requested that Council accept their notification.

<u>Action:</u> Robert Koob moved that the Council accept the list of programs without concerns. Susan Spirey seconded the motion, and it was approved unanimously.

4. For the Good of the Order

John Lewis provided the Council with an update on the activities of the Distance Learning Advisory Committee. He shared that the web site is in operation and currently includes information on courses offered by lowa post high school institutions via distance learning technology. He also provided information concerning discussion with the lowa Department of

Economic Development about an Internet based system in Minnesota. This system provides citizens of Minnesota with current information about educational and employment opportunities in their state.

Minnesota has recently expressed interest in demonstrating the system in other states. After a brief discussion, the Council requested that Mr. Lewis invite a representative to present information concerning the system to the Council at its May meeting.

The meeting was adjourned at 12:30 p.m. The next meeting of the ICCPHSE is scheduled for Wednesday, May 2, 2001, 9:30 a.m. – 2:00 p.m., at Central College in Pella.
