As of March 31, 2002 the ICCPHSE had a balance of \$17,060.94, of which \$13,939.50 was in the operating expense account; \$1,910.77 in the Way-Up Conference account; and, \$1,210.67 in the Carol Kay Memorial Fund account.

5. Presentation by Former University of Iowa President, Willard Boyd.

Mr. Boyd was one of the original founders of the Council. Mr. Boyd spoke on the development and suggested future activities of the ICCPHSE.

He noted that the Council was initially formed to avoid the development of a "Super Board" in Iowa and to improve coordination and collaboration among the various sectors of postsecondary education.

Among his suggestions for future activities were: those for follow-up activities to the Governor's Education Roundtable recommendations to be developed later this month; promoting postsecondary education as one of Iowa's greatest assets; assisting with the recruitment of out-of-state businesses; and assisting with community immigrant projects.

He also asked for non-profit leadership course information from Iowa colleges and universities.

In conclusion, he said that voluntary coordination, like that of the Iowa Coordinating Council, takes time and hard work and is more difficult than going it alone, but it is much more rewarding and worthwhile.

6. Report and Recommendations of the Nominating Committee
